SUMMARY OF ESSENTIAL ELEMENTS OF CITING/REFEREE'S REPORT/INCIDENT FOOTAGE

The Disciplinary Officer received the report from the Match Official:

Warriors were attacking the wing close to the try line. I saw Blue #7 go to tackle the ball carrrier and make contact with the upper body area, but my view of the incident was limited. Both players appeared to me to be reasonably upright at the time of contact. The incident happened directly in front of one of my ARs, Thibaut Reuchet, who immediately raised his flag to signal foul play. Although WRC maintained possession, I immediately blew the whistle.

The report from the AR was that blue #7 had attempted the tackle but made direct contact to the neck of the ball carrier. From my own view of the tackle I expressed that I believed that there had been at least a medium-degree of force to the tackle, which was







confirmed by the AR. It was also reported that the ball carrier had made a quick lateral movement just before contact that likely impacted the tackler's ability to make a clean tackle, however it was asked and confirmed that there was no change in the height of the ball carrier leading into the contact. Based on these facts - direct contact to the neck, no immediate change in height by the ball carrier, and a reasonable degree of force - I made the decision to issue a red card to blue #7.

It should be said that the player's actions after the tackle were exemplary. He immediately apologised to the ball carrier for the tackle in real time and made no effort to contest the card when it was issued. He also went out of his way to shake the ball carrier's hand again before leaving the field.

As the sending off was a result of an assistant referee's report, the Disciplinary Officer also received his report:

Action happened 5 meters from HRC try line and 3 meters from touch line. WRC player #11 had the ball and run towards HRC try line.

WRC #11 did an inside sidestep and got tackle first by HRC player #8 and by HRC player #7.

HRC #7 tackled high WRC #11. HRC #7 left arm made contact with the neck and head of WRC#11, and the arm of HRC#7 acted as a clothesline on the head of WRC#11. There was a high degree of danger (direct contact, dynamic and middle level of force). No mitigation has been identified (the sidestep of WRC#11 just before the tackle hasn't been considered as a mitigation, according to main referee George Mossford).

Video footage was provided by Warriors Rugby Club via YouTube. As per Regulation 17 requirements, audio was removed from the video clips (ie no referee audio link was available) and this was also made available to the Disciplinary Panel.

ESSENTIAL ELEMENTS OF OTHER EVIDENCE (e.g., medical reports)

The Disciplinary Officer requested further information for the Warriors Rugby Club with regards to the potentially injured player. The following was given:

I attended to [The Tackled Ball Carrier] on the field and together with [another technical zone medic] put him on his back, securing his neck while assessing his condition. We did not see any indication he was having any major issues, and after asking him the usual questions and him answering correctly, we helped him back up. After checking how he was while standing (balance was alright) we decided to let him continue playing.

He was substituted several minutes later by the coach on a normal substitution, unrelated to his earlier incident.

SUMMARY OF PLAYER'S EVIDENCE

The Player's club submitted the following:







The board and our player are accepting the reporting of the offense and its conclusion without any contest... The player has personally apologized to Warriors player on the pitch for his risky handling of the situation.

Disciplinary statement

During our defensive effort near our own try line against the Warriors, I became aware at the last moment that the opposition had a numerical advantage on the left side of the ruck. Their player number 10 moved the ball quickly out wide, and I observed that player number 11 (Jiri) had significant space with only a few meters to the try line. I managed to close the distance, and as I prepared to tackle him from the side, I noticed him step infield and lower his body height.

I attempted to execute a clean and legal tackle, initially making contact with his shoulder. Simultaneously, our player number 8 engaged him from a different angle, which effectively stopped his forward momentum. As a result of number 11's sudden change in direction and height, combined with the force of the simultaneous tackle, my arm continued its motion and unfortunately made contact with his head.

Upon realizing the head contact, I immediately attempted to avoid further impact. Player number 11 fell to the ground, and I checked on his condition right away. The on-field officials determined that the incident warranted a red card, and I respectfully left the field. Before exiting, I approached player number 11 to sincerely apologize for the incident, and we later had a respectful and constructive conversation regarding the situation.

As both a player and the captain of my team, I take great pride in upholding the values of fair play and compliance with the laws of the game. This unfortunate event does not reflect my character or intent as a player. I fully understand the seriousness of the incident and the importance of player welfare.

Given the context of the situation, including the dynamic nature of the tackle, the simultaneous contact from another player, the lack of malicious intent, and my immediate concern for the opponent's well-being, I respectfully ask the disciplinary panel to consider these factors when determining the outcome. I remain committed to playing the game safely, fairly, and in the spirit of sportsmanship.

FINDINGS OF FACT

Given The Player's acceptance of the charge and no contest, The Disciplinary Panel considered the officials' statements at the findings of fact and upheld the sending off.
